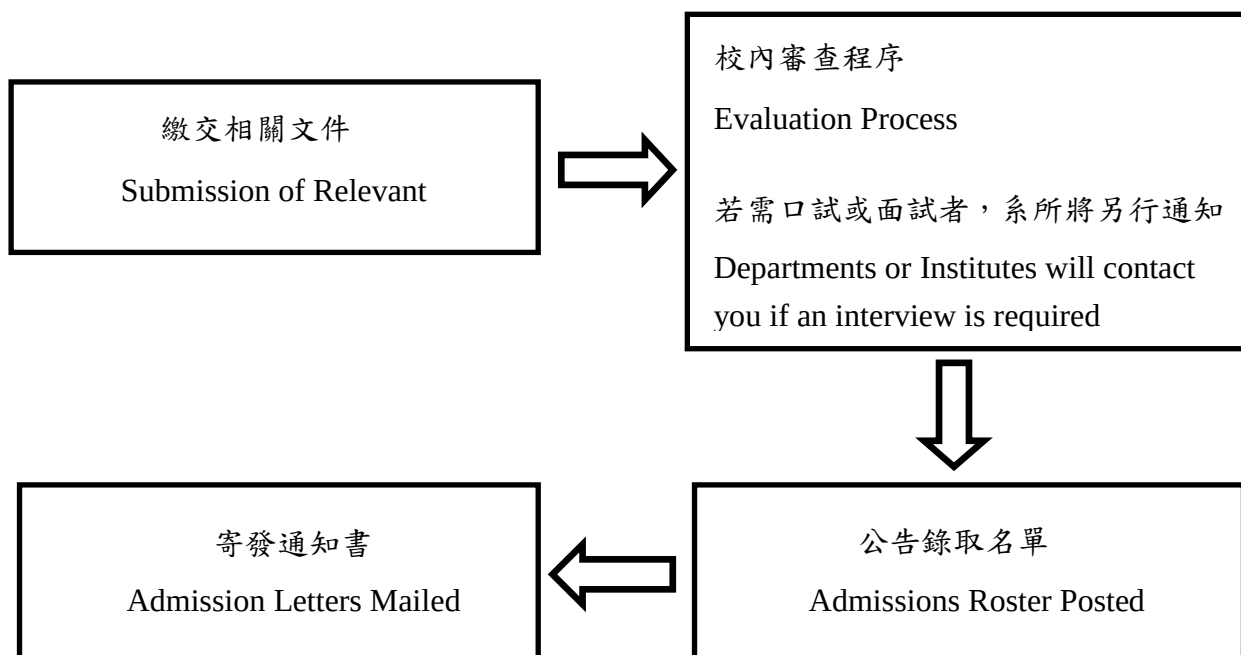

- 2.第二學年起以提供助學金方式，每學期以預扣學雜費支付新台幣壹萬元。

LEE-MING Institute of Technology Foreign Student Scholarship:

Handled in Accordance with 「The Measures for the Establishment of Scholarships」 for Overseas Chinese and Foreign Students of Lee-Ming Institute of Technology.

Students who meet the requirements of the Overseas Chinese and Foreign Students Scholarship Program:

1. In the first academic year, tuition fees, miscellaneous fees and accommodation fees of NTD. 30,000 will be paid in the form of withheld scholarships each semester;
2. Start from second academic year, each semester NTD. 10,000 scholarship is awarded.

一、申請資格 / I. Qualifications:

本校為華文授課，除馬來西亞華裔學生以外之所有外國學生須具有 TOCFL A2 以上證明才可申請就讀。

All subjects in our school are taught in Chinese, all foreign students except Malaysian Chinese students must have TOCFL A2 (The Test Of Chinese as a Foreign Language - Level 2) or above to apply for admission.

1. 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者，得依本簡章申請入學。

An individual of foreign nationality, who has never held nationality status from the Republic of China ("R.O.C.") and who does not possess an overseas Chinese student status at the time of their application, is qualified to apply for admission under this brochure.

外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者，亦得依本簡章規定申請入學：

An individual of foreign nationality, pursuant to the following requirements and who has resided overseas continuously for no less than 6 years is also qualified to apply for admission under this regulation:

(1) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An individual who also is a national of the R.O.C. , but does not hold or has had a household registration in Taiwan.

(2) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.

(3) 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

According to the Education Cooperation Framework Agreement, a foreign national who was selected by a foreign government, organization, or school, and does not hold a household registration from the time of their birth is not subject to the limitations as prescribed in the preceding 2 paragraphs after receiving the approval from the authorized educational government agencies

第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

The six and eight year calculation period as prescribed in Paragraph 2 shall be calculated from the starting date of the semester (February 1st or August 1st) as the designated due date for the time of study.

第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾一百二十日。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term “overseas” as prescribed in Paragraph 2 is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supported proof:

- (4) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education.

- (5) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry of Education, and to which the total length of stay is less than 2 years.

- (6) 交換學生，其交換期間合計未滿二年。

Exchange students, whose length of total exchange is less than 2 years.

- (7) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

具外國國籍並兼具中華民國國籍，且於外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

An individual, who has both foreign and R.O.C. nationalities and has applied for an annulment of their R.O.C. nationality before February 1, 2011, the effective date of this amendment, will then be qualified to apply for admission as an international student under the amendment effective before February 1, 2011 and will not be subject to the limitation as prescribed in Paragraph 2.

2. 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依本招生規定申請入學。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission under these regulations.

3. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者，得依本招生規定申請入學。

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission under these regulations.

- 1.同時申請一個以上系所者，僅能選擇其中一系所報到註冊。

Those applicants who apply for more than one program can only register into one of them.

- 2.報名時繳交之「畢業證書」及「歷年成績單」，除海外臺灣學校所發者外，應依教育部「大學辦理國外學歷採認辦法」規定辦理。最高學歷或同等學力證明文件及成績單(中、英文以外之語文，應加附中文或英文譯本，成績單須註明該校所在地及學制年限)，應經駐外機構驗證，俾供本校審查，否則將視為報名資格不符，已錄取者撤銷錄取及入學資格。

The diploma and transcript submitted for application review shall first be authenticated in accordance with the rules promulgated by the ROC Ministry of Education, except for diplomas and transcripts issued by Overseas Taiwanese or Overseas Chinese Schools.

Documents proving the highest academic qualification or equivalent academic qualifications and transcripts (for languages other than Chinese and English must have a Chinese or English translation attached, and the transcript must indicate the location of the school and the length of schooling), which should be verified by the overseas institution for review by the school., otherwise it will be deemed that the registration qualifications are not met, and the admission and admission qualifications of those who have been admitted will be revoked.

- 3.依教育部規定，凡曾經入學以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再向本校申請入學。若違反此規定並經查證屬實者，取消其入學資格。

In accordance with the regulations promulgated by the Ministry of Education, those who have been dropped out of or withdrawn from school due to failure of their conduct, failure of their academic grade, or found guilty of criminal cases are NOT eligible to apply. Applicants who violate this regulation will have their admission nullified or status as the LIT student revoked.

- 4.已報名或錄取之學生，如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、冒用等不實情事者，未入學者即取消錄取資格；已入學者開除學籍，亦不發給任何學歷證明；如將來在本校畢業後始發現者，除勒令繳銷其學位證書外，並公告取消其畢業資格。

Admission shall be denied and/or the student shall be dismissed from LIT after

admission if there are any violations of the general academic honor code and/or in the authenticity of the applicant's documents. Those who have graduated shall have their diploma revoked.

5. 學生入境前務必在原國家投保商業醫療保險至少 2 日(入境當日起計算)，以防止外籍學生醫療保險尚未啟動，致學生突發狀況就醫時需負擔全額醫療費用。

In order to prevent Foreign Student Health Insurance from being activated and students will have to bear the full medical expenses when seeking medical emergency, so student must apply for commercial medical insurance in their home country for at least 2 days(calculated from date of entry) before entering Taiwan.

6. 外國學生就學期間在臺設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者，喪失外國學生身分，應予退學處分。

International students will be withdrawn from NJIT if their identities of international students have been lapsed by establishing household registrations, moving-in registrations, naturalizing or regaining R.O.C citizenships.

八、報到註冊 / VIII. Registration and Enrollment

錄取生應依入學通知書之規定辦理報到註冊手續，並繳驗護照、畢業證書及成績單，始得註冊入學。

Admitted students should arrive at the LIT campus for registration prior to the date specified on the admission document. Passports and copies of diploma and transcripts, should be presented.

本校採學年學分制，各系學生須修滿規定年限，並修滿各該系規定學分，成績及格者，方得畢業。四年制各系修業年限為四年，至少修滿一二八學分。

The school adopts the academic year credit system. Students of each department must complete the prescribed number of years and complete the required credits of each department. Only those who pass the grade can graduate. The duration of study in each department of the four-year system is four years, with at least 128 credits.

依據黎明技術學院外籍學生華語文能力畢業門檻實施辦法，113 學年度起入學之外籍生必須於畢業前，參加國家華語測驗推動工作委員會（簡稱華測會）辦理之「華語文能力測驗」（TOCFL）檢定，並以進階級（B1、Level 3）（含）以上為通過標準，方能畢業。

According to the Implementation Measures for the Graduation Threshold of Chinese Language Proficiency for Foreign Students of LEE-MING Institute of Technology, foreign students enrolled from the 113th academic year onwards must take the Chinese Language Proficiency Test (TOCFL) test conducted by the National Chinese Language Testing Promotion Committee (hereinafter referred to as the China Testing Committee) before graduation, and pass the advanced level (B1, Level 3) or above (inclusive) before graduation.
