Overseas Chinese/Hong Kong & Macao Students

#### 僑生

指海外出生連續居留迄今,或最近連續居留海外六年以上,並取得僑居地永久或長期居留證件之華裔學生。取得僑居地永久或長期居留證件,得以取得僑居地公民權、永久居留權或以其所 持中華民國護照已加簽僑居身分認定之。僑生身份認定,由僑務委員會為之。

#### Overseas Chinese Students:

Refers to Chinese students who were born overseas and have resided continuously until now, or have recently resided overseas for more than six years, and have obtained permanent or long-term residence certificates in the place of residence. A person who obtains a permanent or long-term residence certificate in the place of overseas residence may obtain citizenship or permanent residency in the place of overseas residence, or be recognized as an overseas Chinese by having his/her Republic of China passport endorsed. The identification of overseas Chinese students is done by the Overseas Chinese Affairs Council.

#### 港澳生:

香港或澳門居民,取得港澳永久居留資格證件,且最近連續居留境外六年以上;並符合香港澳門關係條例第四條規定,未持有外國護照者, 得申請來臺灣地區就學。港澳生身分認定,由教育部為之。

#### Hong Kong & Macao Students:

Hong Kong or Macau residents who have obtained Hong Kong or Macau permanent residence certificates and have resided abroad for more than six consecutive years; and who meet the requirements of Article 4 of the Hong Kong and Macau Relations Ordinance and do not hold foreign passports, may apply to study in Taiwan. The identity of students from Hong Kong and Macao is determined by the Ministry of Education.

## 十三、招生委員會組成 / Committee of Admissions

本校為貫徹公平、公正、公開之精神,設立「黎明技術學院招生委員會」,辦理國際學生產學合作專班招生事宜,招生委員會由校長、教務長、學生事務長、總務長、研究發展處處長、國際暨兩岸事務處處長、國際專修部主任、主任秘書、進修部主任、會計主任、人事主任、圖書資訊中心主任、招生中心主任、通識中心主任、各系(科)主任擔任委員。本委員會置主任委員,由校長兼任之;總幹事由招生中心主任兼任之。

The L.I.T Overseas recruitment committee] was formed with the spirit of fairness and open-minded by the school,to deal with matters regarding on overseas students in college recruitment, the committee consists of the Principal, Office of Secretary, Dean of Academic Affairs, Dean of Student Affairs, Dean of General Affairs, Chief of Research and Development, Dean of International Affairs, Director of International Continuing Education, Chief Secretariat, Director of Continuing Education, Chief Accounting, Chief of Personnel, Department of Library and Information, Director of Admissions, Director from all departments, and all presenting staff are picked by the principal.

## 十四、其他重要注意事項 / Other Important Issues of Registration

#### 1. 華語文要求 Chinese language requirements

- (1) 第一年華語先修班結束前須取得 TOCFL A2 以上,未取得同學依教育部規定退學。 Chinese language specialization must reach TOCFL A2 or above before the end of the first year. Students who have not meet the requirement should withdraw from the school according to the regulations of the Ministry of Education.
- (2) 依據黎明技術學院外籍學生華語文能力畢業門檻實施辦法,113 學年度起入學之外籍生必須於畢業前,參加國家華語測驗推動工作委員會(簡稱華測會)辦理之「華語文能力測驗」(TOCFL)檢定,並以進階級(B1、Level 3)(含)以上為通過標準,方能畢業。

According to the Implementation Measures for the Graduation Threshold of Chinese Language Proficiency for Foreign Students of LEE-MING Institute of Technology, foreign students enrolled from the 113th academic year onwards must take the Chinese Language Proficiency Test (TOCFL) test conducted by the National Chinese Language Testing Promotion Committee (hereinafter referred to as the China Testing Committee) before graduation, and pass the advanced level (B1, Level 3) or above (inclusive) before graduation.

2. 報名時繳交之「畢業證書」及「歷年成績單」,除海外臺灣學校所發者外,應依教育部「大 學辦理國外學歷採認辦法」規定辦理。

The diploma and transcript submitted for application review shall first be authenticated in accordance with the rules promulgated by the ROC Ministry of Education, except for diplomas and

transcripts issued by Overseas Taiwanese or Overseas Chinese Schools.

- 3.依教育部規定,凡曾經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者,不得再向本校申請入學。若違反此規定並經查證屬實者,取消其入學資格。 In accordance with the regulations promulgated by the Ministry of Education, those who have been dropped out of or withdrawn from school due to failure of their conduct, failure of their academic grade, or found guilty of criminal cases are NOT eligible to apply. Applicants who violate this regulation will have their admission nullified or status as the LIT student revoked.
- 4. 已報名或錄取之學生,如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、冒用等不實情事者,未入學者即取消錄取資格;已入學者開除學籍,亦不發給任何學歷證明;如將來在本校畢業後始發現者,除勒令繳銷其學位證書外,並公告取消其畢業資格。 Admission shall be denied and/or the student shall be dismissed from LIT after admission if there are any violations of the general academic honor code and/or in the authenticity of the applicant's documents. Those who have graduated shall have their diploma revoked
- 5. 華語先修期間學生不得辦理轉系或休學;但於正式修讀學士班課程一年後,得申請轉入教育部核定本校辦理「重點產業領域擴大招收僑生港澳學生 及外國學生計畫」之相關系所。 During the Chinese language preparatory period, students are not allowed to transfer departments or take a leave of absence. However, after completing one year of formal bachelor's degree studies, they may apply to transfer to related departments and institutes under the "Implementation Plan to Expand the Admission of Overseas students, Hong Kong and Macau students and foreign students in key industries", which has been approved by the Ministry of Education.
- 6. 外國學生就學期間在臺設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者,喪失外國學生身分,應予退學處分。

International students will be withdrawn from NJIT if their identities of international students have been lapsed by establishing household registrations, moving-in registrations, naturalizing or regaining R.O.C citizenships.

## 十五、申請資格說明/Details of Eligibility

For Applicants who are Overseas Chinese students or Hong Kong and Macau students:申請人之身分資格符合教育部《僑生回國就學及輔導辦法》及《香港澳門居民來臺就學辦法》【附錄三、四】規定者,得申請入學國際專修部,重要規定摘錄如下:

Applicants whose identities meet the "Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan" and "Regulations Regarding Hong Kong and Macau Residents to Study in Taiwan" (Appendix 3 and 4) issued by the Ministry of Education can apply for admission to the International Foundation Program. Important provisions are excerpted as follows:

(一)、身分資格 Identity:

1. 僑生:指海外出生連續居留迄今,或最近連續居留海外六年以上,並取得僑居地永久或長期居留證件之華裔學生。取得僑居地永久或長期居留證件,得以取得僑居地公民權、永久居留權或以其所持中華民國護照已加簽僑居身分認定之。僑生身份認定,由僑務委員會為之。(僑生回國就學及輔導辦法 第 2 條)

Overseas Chinese Students refer to ethnic Chinese students who were born overseas and have lived continuously until now, or, have recently lived overseas for more than 6 years and have obtained permanent or long-term residence certificates in the place of residence. Certificates of permanent or long-term residence could be citizenship, permanent residency in place of overseas residence, or the identification of overseas residence status on the Republic of China passport. The

identification of Overseas Chinese Students shall be determined by the competent authorities of Overseas Chinese affairs. (Article 2, Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan)

2.港澳生:香港或澳門居民,取得港澳永久居留資格證件,且最近連續居留境外六年以上;並符合香港澳門關係條例第四條規定,未持有外國護照者, 得申請來臺灣地區就學。港澳生身分認定,由教育部為之。 (香港澳門居民來臺就學辦法第 2、8 條) Hong Kong and Macau Students refer to people who have obtained permanent residence certificates and have recently lived overseas for more than 6 years and comply with Article 4 of the Laws and Regulations Regarding Hong Kong & Macau Affairs

(https://law.moj.gov.tw/ENG/LawClass/LawAll.aspx?pcode=Q0010003), can apply for studying in Taiwan. The identification of Hong Kong and Macau Students shall be determined by the competent education administrative agencies (Article 2, 8, Regulations Regarding Hong Kong and Macau Residents to Study in Taiwan).

註 1:所稱海外,指大陸地區、香港、澳門以外之國家或地區。所稱境外,指臺灣地 區以外之國家或地區。所謂「連續居留」係指每歷年在國內停留期間未逾一百二十日,連續居留港澳或海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合「僑生回國就學及輔導辦法」(附錄三)第三條及「香港澳門居民來臺就學辦法」(附錄四)第三條規定者,不在此限。報名時請檢附證明文件一併繳交,以利審核。

Note 1: The term "overseas" refers to countries or regions other than Mainland China, Hong Kong, and Macau. The so-called "continuous residence" refers to those who stay in Taiwan for less than 120 days in each calendar year. If the start and end of the period of continuous residence in Hong Kong, Macau, or overseas is not a complete calendar year, the 120-days is calculated by the individual calendar year. Yet, people who are qualified by Article 3, Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan and Article 3, Regulations Regarding Hong Kong and Macau Residents to Study in Taiwan are exempted. Please attach all supporting documents/certificates in the application for review.

Admitted Hong Kong and Macau ethnic Chinese students with foreign nationalities are found their status not in compliance with the regulations of Article 23-1 of the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

An overseas Chinese student who received assistance to be assigned to an educational institution in Taiwan who studied for less than two years because they discontinued their studies for some reason or forfeited their student status may lodge another application to come to Taiwan to study, but only one such reapplication is permitted. However, if the educational institution in Taiwan where the overseas Chinese student was studying considers that the student's conduct or academic performance was unsatisfactory, or if the student violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of the regulations governing student awards and penalties, the student had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan, based on the provisions of this paragraph.

Hong Kong and Macau Student applicants who have studied in Taiwan for less than 2 years and withdrew from school voluntarily may re-apply for admission in Taiwan. However, the opportunity is limited to one time. Moreover, students who have been dismissed by the educational institution that admitted the student as a result of unsatisfactory conduct or of a conviction in criminal case proceedings is not permitted to re-apply for admission to the university or transfer to another university or tertiary college.

Applicants are not allowed to apply or reapply for admission if they have been enrolled in a university in Taiwan (Academy of Preparatory Programs for Overseas Chinese Students in National Taiwan Normal University included), if they have applied for absence from school, or if they have applied for retaining their previous admission.
